Tree Preservation order proposal application to pollard oak tree with over 90% of crown die back to a height of approximately 7m and dismantle and fell the adjacent Field Maple.

This is not on BPC owned land and is being made by KCC.

**Boxley Parish Council** defers to the views of the Tree Officer but would like to see this application approved.

# 25/503299/TPOA 5 Ploughmans Way, Boxley, ME5 9DE

TPO application to one Ash Tree to prune branches from 20m to 10m to try to promote more new growth and to stop the current branches damaging the roof in the house which they are currently touching.

**Boxley Parish Council** defers to the views of the Tree Officer

# 25/503651/TPOA 10 Round Wood Close, Walderslade, Kent, ME5 9UL

Tree Preservation Order application: T1 Oak - Manage the tree under a cyclical pruning programme. Crown reduce the height by 3m from 18m to 14m, and width by 3m from 17m to 14m spread and remove any dead wood and all epicormic growth to manage the size and maintain a healthy growth.

The term Cyclical pruning programme includes the following:-

An annual visual tree assessment to check the structural integrity of the tree to ensure it is safe in the garden location.

Remove any deadwood that appears

Crown thin after possibly two or three years to allow light and air into the crown to maintain the trees health. An application would be make at that point.

Crown reduce again after three to five years depending on how the tree responds to the reduction. A longer time if necessary, if the growth is slow for instance.

The aim is to preserve, maintain and keep safe the mature Oak in the family garden setting.

#### 25/503592/TPOA 15 Podkin Wood, Walderslade, Kent, ME5 9LY

TPO Application to reduce the lateral growth of 1no. Chestnut tree (T001) remove 4m of lateral growth, reduce height by 2m and remove lower branches to clear main stem to 7m. To reduce lateral growth of 2no. Oak trees (T002\_Oak1 and T002\_Oak2) by 2m, remove 4m of lateral growth circumference, reduce height by 2m and remove lower branches to clear main stem to 6m. Remove all arisings from all three trees. **Boxley Parish Council** defers to the views of the Tree Officer

#### 25/503618/NMAMD Keswick Orchard Drive Weavering Kent ME14 5JG

Non material amendment to application 21/506745/FULL for the relocation of the wood burning flue to the South East elevation.

**Boxley Parish Council** have no material planning reasons to object to this application.

Submission of details pursuant to condition 8-(foul sewage treatment) 9-( decentralised and renewable or low-carbon sources of energy) subject to 23/505646/FULL

A letter would be sent to both MP's asking for support in ensuring that Sandling and its residents are respected in the A229 scheme.
